Proposed Boundary Changes

The Local Government Boundary Commission for England (LGBCE) is proposing to change the ward boundaries of Parishes in Buckinghamshire.



Their current proposal recommends splitting New Denham, Willowbank and Kings Island into Iver Ward and the remainder of Denham being a part of the new Gerrards Cross & Denham Ward. The Parish Council do not agree with this proposal and will be writing our response to the recommendations.

The Parish Council would like to thank residents for attending the two public drop-in sessions that were organised to hear about our response to these proposals, and to garner support from the local community.

The two sessions were organised in November, one at the Denham Parish Council Offices and the other session at New Denham Community Centre. Both sessions were very well attended, and you may still be able to send your comments on the above link, which closes on the 5th December 2022.

Denham Parish Council objects most strongly to the annexing of New Denham Ward from the rest of Denham and its inclusion into the new Iver ward.

Denham Parish Council accepts the proposed joining (of all five settlements) of Denham with Gerrards Cross, Fulmer and Hedgerley into a larger ward, provided adequate governance arrangements are put in place.

The proposal to change the current ward arrangements of Denham Parish Council is rejected.
